NATIONAL DIRECTOR REPORT

The Governing met July 7, 2021 in Gillett, WY with 75% present.

Treasure report, we had to cancel 2 conventions, Membership losses, and difficult expenses cuts had to be made. New Company for FMCAssist with better benefits and much lower cost. FMCA did receive a loan from the Government for Paycheck Protection for \$545,623.32. The loan was forgiven. The fiscal year 2020 showed a 4 digit increase where the last 5 years the losses were 6- and 7-digit loss. As of 7-7-2021, our investment account is a plus \$10,373,116. (more details, call)

FMCA is expanding Social Media. (hope you were following the convention on Facebook) New partnership with LIG Solutions, Major medical, Medicare, vision, dental and many other offerings. As mentioned in the previous paragraph, Chubb for FMCAssist.

Passed – Adding "under normal circumstances ",the" Governing Board shall convene …at FMCA International Convention. (a paragraph was added how to convene when uncontrollable circumstances prevent in person.)

Failed – A quorum of the Executive Board shall 60% of its voting members rather than 80%

Passed - To roll dues back to \$50.00 a year

Passed – The text of any proposal with an Executive Board approval level shall be reviewed by the Policy and Procedure Committee and forwarded to the Executive Board no later than (3) days "prior to the Executive Board meeting"

Passed – Added under Nominating Committee, conference calls "will shall" be "setup and" funded by the national office.

Passed – Annual Dues of FMCA <u>"Commercial Members shall</u> be the same as full Family memberships and"

Failed — under Code of Conduct "Agree to be sanctioned for any violation" What a can of worms, what if an employee over slept and was late to work? What if a National Director was speaking from the wrong mike? What if I spoke out at a meeting instead of waiting to be called on? What if someone couldn't make it to a zoom meeting? Etc.

Failed – Under Executive Board Responsibilities. All EB members will agree to stand by EB decisions. EB agree to not to hole spontaneous or preplanned meetings outside called meeting. (no more sitting under awnings and visiting. No more going out to eat together, no more discussions outside the board room to hash out some questions, no more able to call a meeting when charged with a team project, etc.) EB shall process sanction issues that have been received in writing. (if this and the one before passed)

Passed – Constitution Amendments, After Governing Board approval, it took out mailing ballots to the whole membership and replaced with publication in FMCA Magazine (which already existed) adding to that those that receive it electronic. To include rational EB and GB recommendations on proposed amendment and a description of the voting process.

Passed – Statement of Investment policy. To establish a <u>"building fund, capital funds"</u> and set aside funds for future expansion.

Failed – Campaign/Election Activities, "not to be used for expressing opinion or lobby on issues"

Referred back to committee – Traveling on Official Business. (took away Area meetings and Other Area Rallies)

Passed – Chapter and Associate Chapter Application. Cleaned up wording on Chapters change status and to remove the \$35.00 formation fee.

Committees Reports.

The committee on Member Engagement report included a statistic that our average member age is 72 years of age and 2/3rds is 65 or older. We allotted \$10,00 for Market Research to are our customers. Research to find what is needed to identify what the younger age needs. (I remember the old days when the word Family meant kids too, we brought ours and grandchildren) To identify travel trends and forecasts. To find skilled professionals who are knowledgeable of our industry and can speak to the preference and expectations of the younger consumers. (This was a close vote with much discussion -Passed) At our first meeting as I as an official National Vice President, I proposed adding a Youth Committee on the National Level. As President of the Southeast Area, I already have added a Youth Captain to our volunteer Committees. This is not a committee to be used as a babysitter, it is to bring together the youth on the first day so they can get acquainted and have an hour or 2 of activities on the grounds each day of the Conventions/Rallies.

Passed – Approved Tucson, AZ for winter Convention and Lincoln, Nebraska for our summer Convention.

RV Mosquitos and Camping



If anything ever did not go together, it's mosquitos and camping. Here's what you need to know about dealing with these vicious bloodsuckers when you're trying to enjoy a camping trip. Our guest in the Interview is Dr.

Janet McAllister, of the Centers for Disease Control. Since this has been such a horrific year for mosquitos, we thought it would be good to bring back an interview we did with her a while back that explains what we need to know about mosquitos. And we also talk about the growing tick investigation now sweeping the country.

Mosquitos and Camping: Know Your Enemy

Dr. McAllister is the Centers for Disease Control's top expert on mosquitos, a medical entomologist who knows more about mosquitos than you'd think possible including mosquitos and camping.

Here is an edited transcript of the interview highlights: Dr. Janet McAllister

What should we know about mosquitos and camping? Mike Wendland:

In terms of mosquitos and camping and the environment, campsites, tall grass, times of day ... windy conditions ... what are our best options, environmentally, to avoid being bothered by those biting mosquitoes?

Dr. Janet McAllister:

Well, certainly, if there's a lot of vegetation around your campsite like you mentioned, tall grass or bushes, someplace that adult mosquitoes can find harborage in ... those are going to be more likely to have mosquitoes in them, that would then come out and bite.

So, more open areas, as far as vegetation. Also, people don't like to be bitten by any kind of mosquito, but, a lot of the mosquitoes that are going to bite you, are not actually the mosquito that's going to transmit some of these mosquito-borne diseases. Mike Wendland:

I'm curious now. Are there different kinds of mosquitoes? I thought there was only one mosquito?



Are there different kinds of mosquitos? A swarm of mosquitos Dr. Janet McAllister:

Yeah. Absolutely. People think that a

mosquito is a mosquito. Kind of like if you think about dogs ... all dogs are dogs. They may be brown ones and black ones, and big ones,

and little ones, and spotted ones, but they're all dogs. That's not the case. Mosquitoes are more like birds.

People get that a hummingbird is a very different animal from a bald eagle. They eat different things. They do different things. Mosquitoes are the same way. While they all start their life in standing water and end up as this flying pest, they eat different things, they prefer different types of water.

The majority of the mosquito species, actually don't even feed on humans. There are some mosquitoes that are specialized so that they only feed on frogs, which they certainly wouldn't be a problem for us.

Only the female mosquito is a blood sucker



Mike Wendland:

I always heard it was just the female mosquito that bites. Is that true? Or, is that one of the myths?

Dr. Janet McAllister:

That is true. She needs a blood meal to get enough protein, to develop eggs.

Mosquitos are, basically, good for nothing!

Mike Wendland:

Is there any benefit to a mosquito? I mean, do they do anything? People say snakes, for example, I know nobody likes snakes, most people don't, but snakes do good things but what about mosquitoes? Is there any function that they form out there, other than making us glad to go inside at night?

Dr. Janet McAllister:

Well, they do serve as a source of food for other animals. They're not the sole source of food. There's not any particular animal that only eats mosquitoes, and if mosquitoes went away, that animal would suffer. But, they do serve as part of the food chain to us.

But Mosquitos can really make you sick



No one likes mosquitos! Mike Wendland:

The symptoms that somebody has, that should cause them to seek medical assistance ... what are those symptoms? Dr. Janet McAllister:

Really, if you feel bad enough to go to the doctor ... some of the symptoms are going to include a high fever. You may have headaches. Occasionally, there could be a rash. I'm glancing over, because I have a list of my symptoms, here. Body aches, joint pains, vomiting, diarrhea.

These viruses cause kind of a flu-like illness. Certainly, flu is associated with the winter months. If you're having some sort of flu-like illness in the summer months, if they're severe enough, you should be going to the doctor, and trying to figure out what is causing those symptoms.

When are mosquitos most active?

Mike Wendland:

The best time of day or night to avoid mosquitos and camping? Then, sunshine versus cloudy days. Anything that we should know about them if we want to minimize our exposure to getting bit by these vermins.

Dr. Janet McAllister:

Yes. The majority of mosquitoes feed, either at night or right around dusk or dawn. There are some mosquitoes that will bite any time of day or night. Some of the more pesty mosquitoes, like the Aedes albopictus, or the Asian Tiger mosquito, will bite anytime day or night, but they really don't prefer to get out of the shade. If they're in the bright sun, that's gonna be drying on them. That's going to be detrimental for them. So, they tend to not follow them out into bright sunny areas. Certainly, on a cloudy day, they don't have that issue, so, they can hunt you during the day, as well.

Mike Wendland:

Did you say Asian Tiger mosquitoes?

Dr. Janet McAllister:

Yes. Yes.

Mike Wendland:

That sounds like an invasive species. Is that normal ... I mean ... just ...

Dr. Janet McAllister:

Yes, it is an invasive species. It came into the United States, we

think, through the used tire trade, and established itself back in 1986, and has been spreading since then throughout the southeast, and now, the eastern US.

Besides Mosquitos and Camping, we need to be aware of ticks

Mike Wendland:

The other thing that we hear about, are ticks. It seems like we're having an

epidemic, I hear, of ticks. We hear so much more about Lyme disease. I know, I don't think that's ... is that your ... that's not your specialty, or maybe it is, but we're talking mostly mosquitoes. I have to ask about the tick thing. Is that getting worse or better?

Dr. Janet McAllister:


Yes. Certainly, ticks are very important. There are a lot more cases of tick-borne diseases than there are of mosquito-borne diseases. We estimate, there's probably, on the order of 300,000 new cases a year, of Lyme disease.

We have also found several new tick-borne diseases here, in the United States. They're pretty rare, but we're just starting to really, I think, scratch the surface on what's going on in ticks. Mike Wendland:

Before we get off ticks, I know as we travel, I have seen more signs in places that say, "Ticks are now here." It's almost like they're going into areas that were not much of a problem before. Is there any validity to that, or are we just hearing more about it?

Dr. Janet McAllister:

Yeah. Ticks seem to be expanding their ranges. We're starting to see some of the, for example, the main tick that transmits Lyme disease, its range is expanding. It's expanding further to the west, to the south, and to the north. It seems to be moving. We don't know exactly why we're seeing more of the ticks.

RV mold: Seek and destroy!

Dear Chris,

What is the best way to find out if there is mold in our rig? What are the steps that need to be taken if mold is found? —*Mike*

Dear Mike,



Mold is sight and mold is smell! Maybe I've been around these things too long, but I can usually ID a mildewed and moldy coach from a few feet away.

Aside from smelling the offending fungus, it is often visible, but not

always, especially if it has seeped into the carpet and the subfloor is wet and rotting.

A mold test kit is another way to tell if there is something growing in the coach. There are a number of brands available, and are available at **Amazon.com**.

If mold is found, there are steps which can be taken to remediate the infestation. First and foremost is to find the source of moisture and stop it. In humid tropical climates mildew and mold are commonplace, and you don't even have to have a leak to get it. Most of us, however, usually find the fungus growing where there has been some sort of leak. Once the leak is stopped, the area has to be dried and cleaned. If the leak involves the inside of a wall or concealed space, it has to be opened up to air dry or the mold and rot will continue. Amazon has a number of products and resources for mold remediation, and you can look them over here. Note that a hypochlorite solution (e.g., Clorox bleach) works very well, but can damage certain surfaces and materials, so be careful if you plan to use it.
