# Predictable Schedule for Postal Rate Increases to Start in 2022



In September, the U.S. Postal Service announced it will not implement a postage increase in January 2022. The next increase will be in July 2022. Thereafter, it will begin a new regime of twice-yearly increases, beginning in 2023.

When announced, the new plans were contingent upon the approval by the U.S. Court of Appeals for the District of Columbia Circuit of the rate-increase authority created by the Postal Regulatory Commission. The Court has since granted this approval (see article above).

The USPS has provided "rough estimates" of the July 2022 increases: 5.9 percent average for compensatory and 7.9 percent average for noncompensatory products and classes.

Compensatory includes First Class and most Marketing Mail; noncompensatory includes Periodicals, Package Services, and some Marketing Mail.

The two main variables in future increases will be the Consumer Price Index and the mail density measure created by the Postal Regulatory Commission. Following July 2022, the USPS plan is to raise rates based on six months' CPI every January, and six months' CPI *plus* the PRC add-ons every July. The add-ons are mail density, retirement funding of about 1 percent, and noncompensatory make-up of 2 percent. Note that the USPS *is* raising rates on Shipping Services as of Jan. 9, 2022.
